## WHO WE ARE

With over a century of service to children of low-income families, Saint Vincent's Day Home is a nonprofit, nonsectarian agency located in the heart of West Oakland – in the same Victorian house where it was founded in 1911.

Saint Vincent's Day Home provides comprehensive early learning programs for toddlers and preschoolers and a licensed full-day kindergarten. We enroll children ages two to six and are open from 7:30 am to 5:30 pm Monday through Friday.

Our program consists of early learning, nutrition, child care, and health screening, as well as parent education and social services referrals for low-income multi-ethnic families.

# **MISSION STATEMENT**

To provide quality care, early childhood education, and family services to those in greatest need, ensuring that children are educated and nurtured, and their parents are empowered to meet family responsibilities.



# **OUR PROGRAMS**

Saint Vincent's Day Home has a **strong educational focus.** Our Early Childhood Education program serves children from two years to six years old. It includes **developmentally appropriate activities, nutritious meals cooked fresh daily in our kitchen, and socialemotional support.** The program promotes healthy physical, social, emotional, and cognitive development and prepares children for academic success.

#### Our teachers employ a finely honed curriculum,

benchmarks to be reached through daily lesson plans, and daily journaling on each child that charts individual progress toward goals and documents health and behavioral factors critical to the child's success.

The last year has seen the hiring of three new team members to provide programmatic leadership at Saint Vincent's Day Home. David Rodriguez was hired as Program Director. David oversaw the hiring of Emily Doman and Quen Guy to create Saint Vincent's new inclusion team. Together, Emily and Quen work to provide teacher's support so that all of our diverse learners can thrive and learn. Our inclusion team helps support families through the process of connecting to community resources and help coordinate the support services that work with Saint Vincent's Day Home. They have also succeeded in bringing on speech therapy and occupational therapy support to our learners.

**The Programs department is working to create a professional development support plan for all staff.** We have set aside one day each month for staff to collaborate together and receive additional training.

**The Programs department is also overseeing the renovation of two classrooms.** These classrooms are being designed as inclusive, multi-sensory spaces that effectively turn the environment into additional teachers. We consulted with multiple design firms, and sourced feedback from our entire teaching staff to ensure these new classrooms would be truly special. After they are complete, we will proceed to renovate one classroom at a time.

### **SERVING FAMILIES**

**Our Family Services programs are designed to empower families with limited resources** by providing comprehensive support, counseling, parent education, and advocacy services.

Our goal is to encourage strong family connections and build solid foundations for our children's futures. We follow a two-pronged approach, addressing families' immediate needs for childcare and social service referrals, while simultaneously providing children with a strong developmental foundation that will benefit them throughout their lives.

Families benefit from community-based health and social service referrals, parent empowerment programs, and support for family emergencies. By developing strong relationships with Day Home teachers and staff, families gain a better understanding of healthy child development and solution-based parenting.

During the fiscal year 2022-2023, the Family Services Program worked to achieve full student enrollment capacity through community outreach and marketing efforts. Through these efforts, we have increased our enrollment to serve 183 children from 162 families.



## **SHERRY WILLIAMS**



Thirty years ago Sherry and her siblings attended Saint Vincent's as children. It was this formative experience that drove Sherry to enroll her own children in our program.

Sherry's children first came into her life as foster children. She has since begun the process of adopting them. During this time the children have attended SVDH and Sherry has found the experience to be incredibly helpful.

"My children came into the Day Home developmentally struggling with social interaction and speech. Because of the strong focus on activity, gross and fine motor skills-based learning, as well as social interaction, my children were able to progress quickly in a short amount of time."

Sherry shared with us how much she appreciates the extra things we do at SVDH to support her family. Some of the benefits of our programs include healthy meals, dental, hearing, and vision screens.

## **DR. ISHMAN ANDERSON**

My Other Brother

Attending SVDH in Pre-K (1990-1994) profoundly shaped Dr. Ishman's life, giving him confidence to overcome societal labels like "high-risk" or "at-risk" youth. Despite navigating Oakland's inner city, SVDH encapsulated love, affirmation, and essential life skills.

After graduating from McClymonds in 2007, he secured a football scholarship to UC Davis, ultimately earning his Bachelor's from UC Davis, a Master's from UCLA, and a Doctorate in Educational Leadership from SFSU. Currently, as a Professor at SFSU and founder of "My Other Brother," supporting OUSD youth, he reflects on how SVDH laid the foundation for his journey.

The memories of the SVDH playground, the smiles of teachers, and their affirmations remain etched in his mind. These positive experiences cultivated the dopamine that fueled his motivation, persisting through college and beyond, enabling him to defy societal stereotypes and succeed in academia while proudly embracing his identity. As a 34-year-old man, he expresses gratitude to the Day Home for fostering the educational confidence that continues to guide him. SVDH symbolizes a robust foundation for success, grounded in confidence, self-advocacy, and love.
